## Statement of Privacy

Protecting your private information is our priority. This Statement of Privacy applies to the [www.aboms.org](http://www.aboms.org) and American Board of Oral and Maxillofacial Surgery and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to American Board of Oral and Maxillofacial Surgery include [www.aboms.org](http://www.aboms.org) and ABOMS. The ABOMS is a not-for-profit Dental Certifying Board. By using the ABOMS website, you consent to the data practices described in this statement.

## Collection of Personal Information

ABOMS may collect personally identifiable information, such as your name. We may gather additional personal or non-personal information in the future.

Information about your computer hardware and software may be automatically collected by ABOMS. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the ABOMS website.

ABOMS encourages you to review the privacy statements of websites you choose to link to from ABOMS so that you can understand how those websites collect, use and share your information. ABOMS is not responsible for the privacy statements or other content on websites outside of the ABOMS website.

## Use of Personal Information

ABOMS does not sell, rent or lease its customer lists to third parties.

ABOMS may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such trusted partners are prohibited from using your personal information except to provide these services to ABOMS, and they are required to maintain the confidentiality of your information.

ABOMS will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on ABOMS or the site; (b) protect and defend the rights or property of ABOMS; and, (c) act under exigent circumstances to protect the personal safety of users of ABOMS, or the public.

## **Secure Transactions**

When personal information (such as a credit card number) is transmitted to other websites, it is protected through the use of encryption, such as the Secure Sockets Layer (SSL) protocol.
